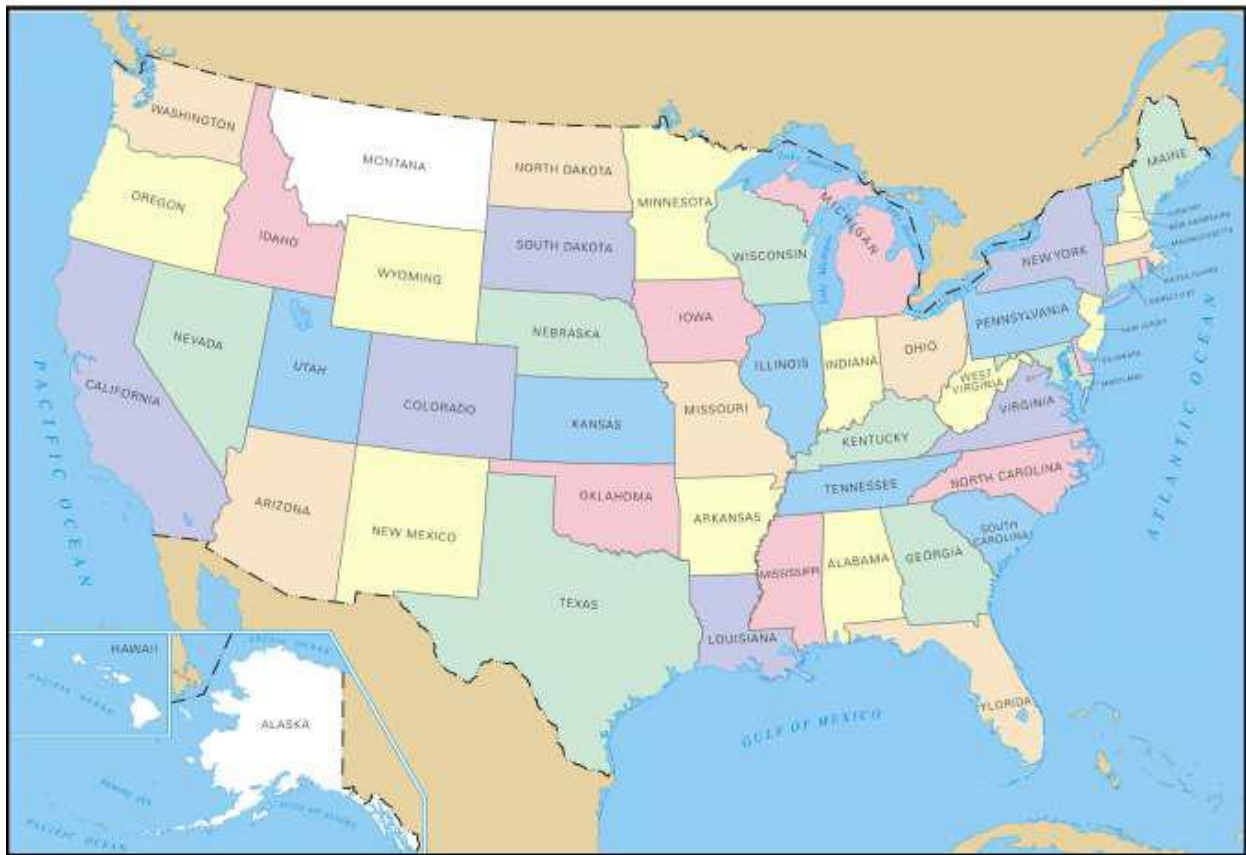


Submarine Industrial Base Suppliers



The Submarine Industrial Base Council (SIBC) represents the 2,698 first tier suppliers and thousands of additional lower tier businesses that make up the nation's submarine industrial base. These companies provide good paying jobs to tens of thousands of highly skilled workers in all 50 states.

Funding listed is the total amount spent or contracted to submarine suppliers over the past five years for major submarine programs. It does not include funding for the two submarine suppliers.
